Bladder Cancer Canada (BCC) is seeking an Executive Director for our national charity. Leading with a passion for BCC's mission and vision that motivates and engages others, the new Executive Director will take our near \$1M charity to the next level by building and diversifying our fundraising revenue, allowing us to expand our vital programs and services.

Bladder Cancer Canada is the first and only Canadian patient advocacy organization dedicated to bladder cancer issues; providing patient support, education and awareness and funding for research. BCC is one of Charity Intelligence's top 10 charities, delivering returns of 6 times for every dollar donated, compared to the average of 1-2 times on the dollar.

Reporting to a highly motivated and progressive Board of Directors, the Executive Director will lead and coach a highly committed staff team of three. This position will work remotely and can be located anywhere in Canada. Since its inception, BCC has been a 100% virtual organization.

## ABOUT BLADDER CANCER CANADA

The story of Bladder Cancer Canada (BCC) began with two people—David Guttman and Jack Moon. Their medical teams tended to the disease in their bodies, but they realized nourishment for their inner beings was missing – and was just as critical to their recovery.

They needed other bladder cancer patients to talk to about their fears and uncertainty. Someone to help them find up-to-date information about diagnosis, treatment options and prognosis. At that time, there was no one to turn to. So, in 2009, they formed Bladder Cancer Canada to fill the void.

Although they were ordinary bladder cancer patients, what they accomplished is extraordinary. Today, BCC is a national, registered charity that has helped thousands of bladder cancer patients and their caregivers to cope with this disease. Our founders' vision was to improve patient support – and it remains the cornerstone of BCC's mission.

#### What Is Our Vision for The Future?

In short: awareness, support and research to create a world where bladder cancer is just a memory.





We're working to achieve this vision through the efforts of volunteers across Canada and with the support of distinguished, leading medical professionals on our Medical Advisory Board and our Research Advisory Board, and in partnership with numerous key stakeholder agencies and private industry. Bladder Cancer Canada's Mission is three-fold:

## **Patient Support and Education**

Our support programming is offered through trained volunteers in a variety of formats. For example, through our online Discussion Forum on our website, our virtual support groups via Zoom, and our 1-1 peer support program by phone/virtual meetings. We are literally just a phone call or a click away for patients and/or caregivers at any time.

We've also created our website as a central information source for bladder cancer patients and their caregivers. Here you will find a wealth of information and education materials about bladder cancer, including Patient Guidebooks written by bladder cancer patients and their caregivers alongside medical experts. There are also excellent webinars and blogs that help to unravel the mysteries of bladder cancer so patients and caregivers can feel more confident and comfortable coping with this disease.

BCC also typically hosts (in a non-COVID environment) several in-person Patient Education Meetings, held several times a year in different cities across Canada. At these meetings patients can meet with each other and hear first-hand stories from other bladder cancer patients and valuable information and insights from medical professionals.

#### **BCC Funded Research**

#### **Our Commitment to Research**

One of the three pillars of Bladder Cancer Canada's mission is to "fund research which pursues the diagnosis, treatment and elimination of bladder cancer." Although bladder cancer is the 5th most common cancer in Canada, it ranks only 21st in terms of research funding out of the 24 most common cancers. Our research commitments endeavour to minimize that disparity, with the long-term *vision to create a world where bladder cancer is just a memory.* 





#### **Our Research Funding**

In 2019, Bladder Cancer Canada funded over \$275,000 in bladder cancer research. Since BCC supported its very first \$25,000 grant in 2012, we have funded over \$1.1 million in research, with an additional \$434,500 in matched funds for a total of more than \$1.5 million. By the end of 2020, we expect to have funded nearly \$1.9 million in bladder cancer research. This incredible milestone has been made possible because of BCC's supportive donors and valued research funding partners.

## Where Does BCC Get Its Funding?



Our funding comes from our annual Bladder Cancer Awareness Walk which is hosted in 20 cities across Canada (virtually last year). We also receive funding through sponsorships and donations from individuals, businesses and community groups along with other donations such as planned gifts and securities.

As a charity, we are keenly aware of the need to keep our expenses low so that we can focus our

financial resources on our mission-related activities. We are truly thankful to our generous donors for their support making a difference in the lives of people living with Bladder Cancer.

## **KEY DUTIES AND RESPONSIBILITIES - EXECUTIVE DIRECTOR**

#### **Leadership and Operational Management**

- Lead national operations and prioritize activities in a manner that ensures an ongoing focus on organization mission, vision and values.
- Work with the Board to create the strategic plan and monitor on an ongoing basis.
- Collaborate with staff, volunteers and other key stakeholders to develop operational goals and plans that deliver on BCC's strategic priorities including patient education and support, awareness, research and advocacy.
- Develop annual budgets in conjunction with Audit, Finance and Risk Committee and oversee financial
  performance to ensure organization is meeting its revenue and expense targets on a short- and longterm basis.
- Manage human resources through the development and implementation of HR best practices and policies.





- Create and support an environment of accountability that facilitates staff understanding of roles and responsibilities through ownership of team and individual goals, and metrics.
- Collaborate with the Board, staff and other volunteers to foster a positive culture that supports
  organizational learning, growth and innovation.
- Oversee and enhance BCC's organizational infrastructure and programming (the latter in collaboration with the Programs & Volunteers Committee) to ensure sustainable operations within a 100% virtual work environment.

#### **Fund Development**

- Lead the development and implementation of an annual fundraising plan in collaboration with the Fund Development Committee that includes existing revenue streams (corporate, individual, foundation gifts, signature and third-party events) and the development of new revenue streams.
- Monitor fundraising activities to ensure ongoing improvements and to manage risk.
- Develop creative, relevant and consistent donor cultivation and stewardship activities according to level of gift.
- Foster and build a culture of philanthropy across the organization to support greater fundraising success.
- Identify, improve, and build fundraising infrastructure and processes e.g., data management, metrics, etc.
- Maintain knowledge on trends in fundraising and use learnings to enhance program development.
- Work collaboratively with staff, volunteers and other key stakeholders to identify, cultivate and solicit
  existing and new donors.

#### Community, Stakeholder and Public Relations

- Develop and maintain relationships with key external stakeholders and broader communities as part
  of BCC's fundraising, awareness and advocacy efforts i.e. Pharma, government, cancer agencies,
  etc.
- Foster and grow community and relevant agency partnerships to advance BCC's strategic objectives and programming.
- Work with communications staff, the Awareness & Communications Committee and national television and media partners to increase BCC's profile locally, provincially and nationally.
- Work with communications staff to deepen and refine all aspects of communications—from web presence to external relations with the goal of creating a stronger brand.
- Participate in national and/or international committees, forums and initiatives that are identified as having high relevance and a positive impact on the profile of BCC.
- Act as a spokesperson for the organization as required.

#### **Governance and Board Relations**

- Work with the Board to ensure that BCC complies with all relevant government rules and regulations.
- Identify and evaluate risks to the organization's people, assets, finances and image and work collaboratively with the Board and staff to implement measures to address and/or mitigate.
- Develop and report on key results and performance indicators to the Board and Committees as part
  of ongoing and annual reporting.
- Participate and provide administrative support to the Board and its three standing committees including Executive, Governance and Nominating and Finance, Audit and Risk Management.
